After that, add \$10. Second race is \$15 after paying for highest race first. JUNIORS may also race in their respective Elite category. No refunds/credits after January 12. Race day licensing available for \$10 (M-W Cat. 5, Juniors only). USAC waiver may be signed race day. Includes USAC insurance fee.

**ENTRY PRIZES:** Every race with 40 or more racers will have a post-race drawing for at least \$200 cash and prizes. See web site for more details.
